# Update your SENTRON Powermanager – and reap the benefits

To make full use of the benefits you gain from continuous developments by updating SENTRON Powermanager versions, you need to have an active subscription. This subscription not only applies to version numbers but also allows you to upgrade for free to any version released within the booked subscription period. The period is extended via SUR (Subscription Renewal) or SUS (Subscription reStart) units. The optimal choice and combination of these subscription period units vary from one project to another and are essentially done via the current period and site value of the SENTRON Powermanager project in progress.

# SUBscription Renewal (SUR) and SUBscription reStart (SUS)



The number of SUS or SUR units needed is equal to the project's site value (e.g., a site value of 10 means that 10 x SUS/SUR units must be purchased).

The site value can be checked in the LMU module of the current SENTRON Powermanager.

SUR list price per unit: €6.63

SUS list price per unit: €13.80

Upgrade period means: The user can update to all versions released during this period.

(This does not mean that the user can carry out an upgrade only during this period.)

## SUBscription Renewal (SUR)

The original end of the subscription period for version updates is extended for another 12 months.

Option for an upgrade to each new version released within this period.

SUR units may be purchased any number of times.

Since each SUR order only extends the current subscription, we recommend an SUS-based upgrade instead of 3 x SUR-based upgrades after approximately 2.5 years.

Although the system can continue to be used, it will run without the new functions of the later versions.

Critical updates, such as security patches, can be carried out and are excluded from the subscription price.

## SUBscription reStart (SUS)

The subscription for version upgrades is restarted. The end of the subscription period is set to 12 months after the restart.

Option for an upgrade to each new version released within this period.

# Extend your subscription quickly and easily



For the update, you will need the site ID and your individual site value, both of which can be found in the LMU module of your SENTRON Powermanager. The site value enables you to easily calculate the cost of the necessary SUR or SUS orders:  
Site value = SUR or SUS units needed



You order the units (either SUR or SUS) from the Industry Mall.



You then receive a delivery note, and the expiration date is automatically changed in the system.

## Order numbers for SUS or SUR units:

### Extend the subscription period by 12 months

SUR unit:

### Restart the subscription period for 12 months

SUS unit:

7KN2713-8CE40-0YC0

The number of necessary units is derived from the site value on a project-specific basis.
